An individual, organization, or ANC is alleging an error in the determination or decision made by an administrative officer in the administration or enforcement of the Zoning Regulations of the District of Columbia (Regulations) regarding property within your ANC's boundaries. This appeal was filed on <u>September 13, 2017</u> through the Interactive Zoning Information System (IZIS).

Appeal of AMT-Varnum, LLC, pursuant to 11 DCMR Subtitle Y § 302, from the decision made on August 23, 2017 by the Zoning Administrator, Department of Consumer and Regulatory Affairs, to deny building permit B1611940, to construct a new, three-story flat in the RF-1 Zone at premises 1523 Varnum Street, NW. (Square 2698, Lot 46).

- This list comprises the full record in the case. Simply click "View" on any document you wish to see, and it will open a PDF document in a separate window.

HOW TO PARTICIPATE IN THE CASE

As described in the Zoning Regulations of the District of Columbia (Regulations), the affected ANC is an automatic party to the case and Board gives "great weight" to its written report.

Visit <u>http://dcoz.dc.gov/resources/ANC_Filing/index.shtm</u> for instructions on how to file the ANC report (Form 129) through the Interactive Zoning Information System (IZIS). Though ANC reports may be filed at any time prior to the Board's final deliberation on the case, the ANC is strongly
