Notice is hereby given that the Board of Zoning Adjustment (Board) will hold a public hearing on **Wednesday, December 20, 2017 at 9:30 am**, at the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4<sup>th</sup> Street, N.W., Suite 220 South, Washington, D.C., 20001, concerning the following application:

**Application of Benjamin Flowers**, pursuant to 11 DCMR Subtitle X, Chapter 9, for special exceptions under the non-conforming structure requirements of Subtitle C § 202.2, under Subtitle G § 1200 from the lot occupancy requirements of Subtitle G § 405.2 and from the side yard requirements of Subtitle G § 406.2, and under Subtitle G § 1200 from the rear yard requirements of Subtitle G § 405.2 to construct a two-story rear addition to an existing one-family dwelling in the MU-4 Zone at premises 508 7th Street S.E. (Square 903, Lot 23).

**WHY YOU ARE RECEIVING THIS NOTICE**

An Applicant in your neighborhood is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district. The Zoning Regulations of the District of Columbia (Regulations) require such applicants to appear before the Board at a public hearing to make their case. The Regulations also require that notification of the public hearing be provided to property owners within 200 feet of the subject property indicated in the application, based on DC Office of Tax and Revenue records.

**HOW TO FAMILIARIZE YOURSELF WITH THE CASE**

In order to review exhibits in the case, follow these steps:

- Visit the Office of Zoning (OZ) website at <http://dcoz.dc.gov>
- Under “Services”, click on “Interactive Zoning Information System”.

- Enter the BZA application number indicated above and click the search button.
- The search results should produce the case on the right. Click “View Details”.
- Click “View Full Log”.
- This list comprises the full record in the case. Simply click “View” on any document you wish to see, and it will open a PDF document in a separate window.
