Application of Mala Mahmood, pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception under the residential conversion regulations of Subtitle U § 320.2, to construct a rear addition and convert an existing one-family dwelling into a three-unit apartment house in the RF-1 Zone at premises 1135 Morse Street N.E. (Square 4070, Lot 145).
