An Applicant within the boundaries of your ANC Single Member District is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district. This application was filed on October 23, 2017 through the Interactive Zoning Information System (IZIS).

Application of The Federation of State Medical Boards, pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception from the use provisions under Subtitle U § 203.1(n), and pursuant to Subtitle X, Chapter 10, for an area variance from the gross floor area requirements of Subtitle U § 203.1(n)(2), to use the existing residential building as an office for a non-profit organization in the R-3 at premises 2118 Leroy Place N.W. (Square 2531, Lot 49).
