An Applicant within the boundaries of your ward is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district. This application was filed on October 20, 2017 through the Interactive Zoning Information System (IZIS).

Kress Memorial Hearing Room, One Judiciary Square, at 441 4th Street, N.W., Suite 220 South, Washington, D.C., 20001, concerning the following application:

Application of Gary Lesinski, pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception under Subtitle D § 5201 from the lot occupancy requirements of Subtitle D § 304.1, to construct a rear deck addition to an existing one-family dwelling in the R-3 Zone at premises 5110 Kansas Avenue N.W. (Square 3256, Lot 80).
