**Application of Kimberly Ziegler,** pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception under Subtitle E § 5201, from the upper floor addition requirements of Subtitle E § 206.1, and from the lot occupancy requirements of Subtitle E § 304.1 to construct a rear and third story addition to an existing one-family dwelling in the RF-1 Zone at premises 1139 6th Street N.E. (Square 855, Lot 236).
