

Notice is hereby given that the Board of Zoning Adjustment (Board) will hold a public hearing on Wednesday, February 7, 2018 at 9:30 am, at the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4th Street, N.W., Suite 220 South, Washington, D.C., 20001, concerning the following application:

Application of C&S Development, LLC, pursuant to 11 DCMR Subtitle X, Chapter 9, for special exceptions pursuant to the inclusionary zoning dimensional modifications of Subtitle C § 1002.2, and under Subtitle E § 5201 from the rear addition requirements of Subtitle E § 205.5 to subdivide the existing lot into three new lots and construct three flats in the RF-1 Zone at premises 2610 4th Street N.E. (Square 3551, Lot 801).

WHY YOU ARE RECEIVING THIS NOTICE

An Applicant in your neighborhood is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district. The Zoning Regulations of the District of Columbia (Regulations) require such applicants to appear before the Board at a public hearing to make their case. The Regulations also require that notification of the public hearing be provided to property owners within 200 feet of the subject property indicated in the application, based on DC Office of Tax and Revenue records.

HOW TO FAMILIARIZE YOURSELF WITH THE CASE
