Application of 1800 Newton St. NE LLC, pursuant to 11 DCMR Subtitle X, Chapter 9, for special exceptions under the nonconforming use requirements of Subtitle C § 204.9, and under Subtitle C § 703 from the parking requirements for an expansion or change of use of Subtitle C § 705, to convert two existing commercial spaces into two residential units in an existing building in the R-1-B Zone at premises 1800 Newton Street N.E. (Square 4202, Lot 191).

### WHY YOU ARE RECEIVING THIS NOTICE

An Applicant in your neighborhood is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district. The Zoning Regulations of the District of Columbia (Regulations) require such applicants to appear before the Board at a public hearing to make their case. The Regulations also require that notification of the public hearing be provided to property owners within 200 feet of the subject property indicated in the application, based on DC Office of Tax and Revenue records.
