Notice is hereby given that the Board of Zoning Adjustment (Board) will hold a public hearing on <u>Wednesday</u>, <u>February 21</u>, <u>2018 at 9:30 am</u>, at the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4<sup>th</sup> Street, N.W., Suite 220 South, Washington, D.C., 20001, concerning the following application:

**Application of LHO Washington Hotel three, LLC**, pursuant to 11 DCMR Subtitle X, Chapter 9, for special exceptions from the use permissions under Subtitle U § 504.1(f), and from the penthouse requirements of Subtitle C § 1500.3(c) to construct a new penthouse restaurant in an existing hotel in the MU-15 Zone at premises 1315 16th Street N.W. (Square 195, Lot 846).

## WHY YOU ARE RECEIVING THIS NOTICE

An Applicant in your neighborhood is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district. The Zoning Regulations of the District of Columbia (Regulations) require such applicants to appear before the Board at a public hearing to make their case. The Regulations also require that notification of the public hearing be provided to property owners within 200 feet of the subject property indicated in the application, based on DC Office of Tax and Revenue records.
