Application of Kate and Matthew Gallery, pursuant to 11 DCMR Subtitle X, Chapter 9, for special exceptions under Subtitle E § 5201 from the lot occupancy requirements of Subtitle E § 304.1 and the nonconforming structure requirements of Subtitle C § 202.2, to construct a two-story, rear addition to an existing one-family dwelling in the RF-1 Zone at premises 656 Independence Avenue S.E. (Square 870, Lot 62).

#### WHY YOU ARE RECEIVING THIS NOTICE

An Applicant in your neighborhood is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district.
