An Applicant within the boundaries of your ANC Single Member District is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district. This application was filed on December 27, 2017 through the Interactive Zoning Information System (IZIS).

(Square 763, Lot 2).
