## REFERRAL MEMORANDUM AND NOTICE OF PUBLIC HEARING

An Applicant within the boundaries of your ANC area is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district. This application was filed on <u>December 28</u>, <u>2017</u> through the Interactive Zoning Information System (IZIS).

A public hearing has been scheduled by the Board of Zoning Adjustment (Board) on <u>Wednesday</u>, <u>March 7, 2018 at 9:30 am</u>, at the Jerrily R. **Application of Milestone East Capitol 4, LLC**, pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception under the new residential development provisions of Subtitle U § 421, and pursuant to Subtitle X, Chapter 10, for variances from the floor area ratio requirements of Subtitle F § 302, the lot occupancy requirements of Subtitle F § 304, and the rear yard requirements of Subtitle F § 305, to construct a new 90-unit apartment house and retain seven existing apartment houses in the RA-1 at premises 127 35th Street S.E. (Square 5413, Lot 802).
