A public hearing has been scheduled by the Board of Zoning Adjustment (Board) on <u>Wednesday</u>, <u>March 21, 2018 at 9:30 am</u>, at the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4<sup>th</sup> Street, N.W., Suite 220 South, Washington, D.C., 20001, concerning the following application:

**Application of District of Columbia,** pursuant to 11 DCMR Subtitle X, Chapter 9, for special exceptions under Subtitle C § 1610.2 from the lot occupancy requirements of Subtitle C § 1603, under Subtitle C § 703 from the minimum vehicle parking requirements of Subtitle C § 701, under Subtitle C § 714.3 from the surface parking screening requirements of Subtitle C § 714.2, and under Subtitle C § 807.2 from the long term bicycle parking requirements of Subtitle C § 802, to construct a new public library in the R-3 Zone at premises 900 Wesley Place S.W. (Square 542, Lot 87).
