An individual, organization, or Advisory Neighborhood Commission (ANC) is alleging an error in the determination or decision made by an administrative officer in the administration or enforcement of the Zoning Regulations of the District of Columbia (Regulations). This appeal was filed on January 8, 2018 through the Interactive Zoning Information System (IZIS).

Appeal of Berkley Smallwood, pursuant to 11 DCMR Subtitle Y § 302, from the determination made on November 28, 2017 by the Zoning Administrator, Department of Consumer and Regulatory Affairs, to refuse further processing of building permit B1801942, to permit the renovation of a flat in the RF-1 Zone at premises 3652 Park Place N.W. (Square 3034, Lot 202).
