Application of Granite LLC, pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception under the rear yard requirements of Subtitle I § 205.1, to construct an addition to an existing building to establish a museum and conference center with associated office use in the D-6 Zone at premises 1501-1505 Pennsylvania Avenue, N.W. (Square 221, Lots 29, 810, and a portion of a public alley to be closed).

#### WHY YOU ARE RECEIVING THIS NOTICE

An Applicant in your neighborhood is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district.
