Application of Newton Park Apartments Condominium Unit Owners Association, pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception under the residential conversion regulations of Subtitle U § 320.2, and pursuant to Subtitle X, Chapter 10, for a variance from the residential conversion requirements of U § 320.2(d), to allow a three-unit apartment house in the RF-1 Zone at premises 452 Newton Place, N.W. (Square 3036, Lot 89).

WHY YOU ARE RECEIVING THIS NOTICE

An Applicant in your neighborhood is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district.
