REFERRAL MEMORANDUM AND NOTICE OF PUBLIC HEARING

An Applicant within the boundaries of your ward is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district. This application was filed on January 15, 2018 through the Interactive Zoning Information System (IZIS).

A public hearing has been scheduled by the Board of Zoning Adjustment (Board) on **Wednesday, April 4, 2018 at 9:30 am**, at the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4th Street, N.W., Suite 220 South, Washington, D.C., 20001, concerning the following application:

Application of 404 Newcomb, LLC, pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception under Subtitle D § 306.4 from the rear addition requirements of Subtitle D § 306.3, and pursuant to Subtitle X, Chapter 10, for a use variance from the nonconforming use requirements of Subtitle C § 204.3, to convert an existing community residence facility into a four-unit apartment house in the R-3 zone at premises 404 Newcomb Street S.E. (Square 5996, Lot 48).
