Notice is hereby given that the Board of Zoning Adjustment (Board) will hold a public hearing on **Wednesday, March 28, 2018 at 9:30 am**, at the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4<sup>th</sup> Street, N.W., Suite 220 South, Washington, D.C., 20001, concerning the following application:

**Application of Kline Operations**, pursuant to 11 DCMR Subtitle X, Chapter 9, for special exceptions under Subtitle I § 205.5 from the rear yard requirements of Subtitle I § 205.1, and under Subtitle C § 1504 from the penthouse setback requirements of Subtitle C § 1502.1(c)(4), and pursuant to Subtitle X, Chapter 10, for variances from the court requirements of Subtitle I § 207.1, and from the loading berth requirements of Subtitle C § 901.1, to construct a new 11-story hotel in the D-4-R at premises 925 5th Street N.W. (Square 516, Lots 827, 828, 829 and 833).

**WHY YOU ARE RECEIVING THIS NOTICE**

An Applicant in your neighborhood is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district.
