Application of Kline Operations, pursuant to 11 DCMR Subtitle X, Chapter 9, for special exceptions under Subtitle I § 205.5 from the rear yard requirements of Subtitle I § 205.1, and under Subtitle C § 1504 from the penthouse setback requirements of Subtitle C § 1502.1(c)(4), and pursuant to Subtitle X, Chapter 10, for variances from the court requirements of Subtitle I § 207.1, and from the loading berth requirements of Subtitle C § 901.1, to construct a new 11-story hotel in the D-4-R at premises 925 5th Street N.W.
