Notice is hereby given that the Board of Zoning Adjustment (Board) will hold a public hearing on **Wednesday, April 11, 2018 at 9:30 am**, at the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4th Street, N.W., Suite 220 South, Washington, D.C., 20001, concerning the following application:

Application of Sons of Italy Foundation, pursuant to 11 DCMR Subtitle X, Chapter 9 for a special exception under the non-profit use provisions of Subtitle U § 203.1(n), and pursuant to 11 DCMR Subtitle X, Chapter 10, for an area variance from the gross floor area requirements of Subtitle U § 203.1(n)(2), to continue a non-profit office use in the RF-3 District at premises 219 E Street N.E. (Square 755, Lot 32).

WHY YOU ARE RECEIVING THIS NOTICE

An Applicant in your neighborhood is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district. The Zoning Regulations of the District of Columbia (Regulations) require such applicants to appear before the Board at a public hearing to make their case. The Regulations also require that notification of the public hearing be provided to property owners within 200 feet of the subject property indicated in the application, based on DC Office of Tax and Revenue records.
