**Application of 1766 Lanier NW, LLC,** pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception under Subtitle U § 320.2, to construct a rear three-story addition and convert an existing residential building into a three-unit apartment house in the RF-1 Zone at premises 1766 Lanier Place N.W. #### WHY YOU ARE RECEIVING THIS NOTICE
