An Applicant within the boundaries of your ward is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district. This application was filed on March 8, 2018 through the Interactive Zoning Information System (IZIS).

Application of Fort Totten South LLC, pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception under the zone boundary line provisions of Subtitle A § 207.2, and under Subtitle G § 409.1 from the side yard requirements of Subtitle G § 406.1, to construct a mixed-use residential and retail development in the MU-4 and R-2 Zones at premises 5543-5575 South Dakota Avenue N.E. (Square 5760, Lot 22 and Parcel 125/30).
