#### **REFERRAL MEMORANDUM AND NOTICE OF PUBLIC HEARING**

An Applicant within the boundaries of your ANC Single Member District is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district. This application was filed on March 9, 2018 through the Interactive Zoning Information System (IZIS).

A public hearing has been scheduled by the Board of Zoning Adjustment (Board) on <u>Wednesday, May</u> <u>16, 2018 at 9:30 am</u>, at the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4<sup>th</sup> Street, N.W., Suite 220 South, Washington, D.C., 20001, concerning the following application:

**Application of Deborah Van Buskirk**, pursuant to 11 DCMR Subtitle X, Chapter 9, for special exceptions under Subtitle E § 5201 from the accessory building gross floor area limitations of Subtitle E § 5004.2(b), and from the accessory building rear setback requirements of Subtitle E § 5004.1, and pursuant to Subtitle X, Chapter 10, for a variance from the lot occupancy requirements of Subtitle E § 304.1, to permit an existing one-story accessory building in the RF-1 zone at premises 445 15th Street S.E. (Square 1062, Record Lot 52).

# HOW TO PARTICIPATE IN THE CASE

As described in the Zoning Regulations of the District of Columbia (Regulations), the affected ANC is an automatic party to the case and the Board gives "great weight" to its written report. Visit <u>http://dcoz.dc.gov/resources/ANC\_Filing/index.shtm</u> for instructions on how to file the ANC report (Form 129) through the Interactive Zoning Information System (IZIS).
