Application of MED Developers, LLC, pursuant to 11 DCMR Subtitle X, Chapter 9, for special exceptions under the use provisions of Subtitle U § 203.1(f), and under Subtitle C § 703.2 from the minimum parking requirements of Subtitle C § 701.5, to construct a new continuing care retirement community in the R-1-B Zone at premises 2619-2623 Wisconsin Avenue N.W. (Square 1935, Lots 44 and 812).

WHY YOU ARE RECEIVING THIS NOTICE

An Applicant in your neighborhood is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district.
