Application of Dale Denton and Morgan Washburn, pursuant to 11 DCMR Subtitle X, Chapter 9, for special exceptions under Subtitle C § 1504 from the penthouse setback requirements of Subtitle C § 1502.1(b) and (c), under Subtitle E §§ 5007 and 5201 from the accessory structure rear setback requirements of Subtitle E § 5004.3, and under Subtitle E § 5201 from the rear yard requirements of Subtitle E § 306.1, and pursuant to Subtitle X, Chapter 10, for a variance from the lot occupancy requirements of Subtitle E § 304.1 to construct a rear deck and a rear roof deck addition and convert the existing residential care facility to a flat in the RF-1 Zone at premises 1208 T Street N.W. WHY YOU ARE RECEIVING THIS NOTICE

The Regulations also require that notification of the public hearing be provided to property owners within 200 feet of the subject property indicated in the application, based on DC Office of Tax and Revenue records.
