An Applicant within the boundaries of your ward is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district. This application was filed on March 26, 2018 through the Interactive Zoning Information System (IZIS).

A public hearing has been scheduled by the Board of Zoning Adjustment (Board) on Wednesday, May 23, 2018 at 9:30 am, at the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4th Street, N.W., Suite 220 South, Washington, D.C., 20001, concerning the following application:

Application of MED Developers, LLC, pursuant to 11 DCMR Subtitle X, Chapter 9, for special exceptions under the use provisions of Subtitle U § 203.1(f), and under Subtitle C § 703.2 from the minimum parking requirements of Subtitle C § 701.5, to construct a new continuing care retirement community in the R-1-B Zone at premises 2619-2623 Wisconsin Avenue N.W. (Square 1935, Lots 44 and 812).
