An Applicant within the boundaries of your ward is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district. This application was filed on April 17, 2018 through the Interactive Zoning Information System (IZIS).

**Application of CDDC 1735-1737 10th St NW LLC**, pursuant to 11 DCMR Subtitle X, Chapter 9, for special exceptions under Subtitle C § 703.2 from the minimum parking requirements of Subtitle C § 701.5, and pursuant to Subtitle X, Chapter 10, for variances from the lot occupancy requirements of Subtitle E § 304.1, the rear yard requirements of Subtitle E § 306.1, and the side yard requirements of Subtitle E § 307.1, to construct two new flats in the RF-1 Zone at premises 1735 and 1737 10th Street N.W. (Square 363, Lots 105 and 106).
