**Application of Compass Coffee**, pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception under Subtitle U § 513.1(n) from the use requirements of Subtitle U § 512.1(d)(3), to permit a coffee/prepared foods shop with more than 18 seats in the MU-4 Zone at premises 1351 Wisconsin Avenue N.W. (Square 1243, Lot 75).
