An individual, organization, or ANC is alleging an error in the determination or decision made by an administrative officer in the administration or enforcement of the Zoning Regulations of the District of Columbia (Regulations) regarding property within your ward's boundaries. This appeal was filed on April 25, 2018 through the Interactive Zoning Information System (IZIS).

You are hereby notified that on **Wednesday, July 11, 2018 at 9:30 am**, at the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4th Street N.W., Suite 220 South, Washington, D.C., 20001, a public hearing will commence concerning the following appeal:

Appeal of Hilary Dove and Ranieri Cavaceppi, pursuant to 11 DCMR Subtitle Y § 302, from the determination made on April 6, 2018 by a Program Analyst in the Office of the Zoning Administrator, Department of Consumer and Regulatory Affairs, that the placement of three air conditioning compressor units in a side yard did not violate the side yard setback requirements and was not a cause for zoning enforcement action in the R-1-B Zone at premises 4400 Albemarle Street N.W. (Square 1590, Lot 43).
