Notice is hereby given that the Board of Zoning Adjustment (Board) will hold a public hearing on **Wednesday, July 25, 2018 at 9:30 am**, at the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4<sup>th</sup> Street, N.W., Suite 220 South, Washington, D.C., 20001, concerning the following application:

**Application of Royal Norwegian Embassy**, pursuant to 11 DCMR Subtitle X, Chapter 2, to renovate and expand a chancery by renovating the exterior, and constructing an addition to the existing Norwegian chancery building in the R-12 Zone at premises 2720 34<sup>th</sup> Street N.W. and 3401 Massachusetts Avenue N.W. (Square 1939, Lot 39).

**WHY YOU ARE RECEIVING THIS NOTICE**

A Foreign Mission is requesting permission to locate, replace, or expand a chancery use in a location where a chancery use is not permitted as a matter of right for the zoning district. The Zoning Regulations of the District of Columbia (Regulations) require such applicants to appear before the Board at a public hearing to make their case. The Regulations also require that notification of the public hearing be provided to property owners within 200 feet of the subject property indicated in the application, based on DC Office of Tax and Revenue records.

**HOW TO FAMILIARIZE YOURSELF WITH THE CASE**

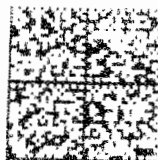
