Notice is hereby given that the Board of Zoning Adjustment (Board) will hold a public hearing on **Wednesday, July 18, 2018 at 9:30 am**, at the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4th Street, N.W., Suite 220 South, Washington, D.C., 20001, concerning the following application:

Application of Community Three Grimke, LLC, pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception under Subtitle K § 813 from the rear yard requirements of Subtitle K § 805.1, and pursuant to Subtitle X, Chapter 10, for variances from the parking access requirements of Subtitle C § 711.3(b), and from the drive aisle width requirements of Subtitle C § 712.5, to renovate and expand the existing former school building and convert it to a mixed-use building in the ARTS-2 Zone at premises 1925 Vermont Avenue N.W. (Square 361, Lot 827).

WHY YOU ARE RECEIVING THIS NOTICE

An Applicant in your neighborhood is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district. The Zoning Regulations of the District of Columbia (Regulations) require such applicants to appear before the Board at a public hearing to make their case. The Regulations also require that notification of the public hearing be provided to property owners within 200 feet of the subject property indicated in the application, based on DC Office of Tax and Revenue records.

HOW TO FAMILIARIZE YOURSELF WITH THE CASE

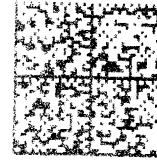
