WHEREAS, ON MARCH 27, 2006, THE GEORGE WASHINGTON UNIVERSITY POLICE DEPARTMENT WAS AWARDED ACCREDITATION FROM THE COMMISSION ON ACCREDITATION FOR LAW ENFORCEMENT AGENCIES ("CALEA");

WHEREAS, THE DEPARTMENT BECAME A PART OF THE SELECT GROUP OF COLLEGE AND UNIVERSITY POLICE DEPARTMENTS IN THE COUNTRY FORMALLY RECOGNIZED BY THE ASSOCIATION, LESS THAN 1% TOTAL;

WHEREAS, THIS ACCOMPLISHMENT WILL ALLOW THE GEORGE WASHINGTON UNIVERSITY POLICE DEPARTMENT TO BE RECOGNIZED AS AN ELITE FORCE AMONG UNIVERSITY POLICE FORCES NATIONWIDE;

WHEREAS, THE GEORGE WASHINGTON UNIVERSITY POLICE DEPARTMENT WAS ESTABLISHED IN 1970 TO PROTECT AND SERVE THE GEORGE WASHINGTON UNIVERSITY AND SURROUNDING FOGGY BOTTOM/WEST END COMMUNITY BY PROVIDING PROFESSIONAL LAW ENFORCEMENT SERVICES AND ACTIVELY PROMOTING COMMUNITY INVOLVEMENT THROUGH PROGRESSIVE COMMUNITY POLICING STRATEGIES AND A COMMITMENT TO EDUCATION;

WHEREAS, THE GEORGE WASHINGTON UNIVERSITY POLICE DEPARTMENT HAS MADE A COMMITMENT TO CONTINUING TO STRENGTHEN ITS RELATIONSHIP WITH THE SURROUNDING NEIGHBORHOOD RESIDENTS AND HAS ESTABLISHED A NEIGHBORHOOD ACTION TEAM ("NAT") UNIT TO RESPOND SPECIFICALLY TO QUALITY OF LIFE ISSUES REPORTED BY GEORGE WASHINGTON UNIVERSITY'S FOGGY BOTTOM/WEST END NEIGHBORS;

WHEREAS, THE DEPARTMENT HAS GROWN TO OVER 160 INDIVIDUALS WHO ARE DEDICATED TO EXHIBITING "PRIDE AND PROTECTION IN SERVICE," SELFLESSLY SERVING THE MEMBERS OF THE SURROUNDING COMMUNITY;

WHEREAS, DURING THE PAST YEAR, MEMBERS OF THE DEPARTMENT HAVE PROVIDED COMMENDABLE SERVICE TO OVER 1500 PEOPLE A DAY, RESPONDED TO OVER 300,000 CALLS FOR SERVICE AND MAINTAINED A FRIENDLY AND SAFE ENVIRONMENT ON AN URBAN CAMPUS WITH MORE THAN 25,000 COMMUNITY MEMBERS;
