Dear Chairperson Mitten:

On behalf of the applicant, The George Washington University (“GW”), enclosed please find a check for the hearing fees for the above-mentioned cases. The enclosed check is in the amount of \$166,500.10.

Pursuant to § 3180.1(b)(3), the fee for the processing of a new or revised campus plan is \$5,000.00.

In ZC Case No. 06-12, GW requests both a Zoning Map Amendment and review of a Planned Unit Development. Pursuant to § 3041.5, in an application that combines two or more actions under Chapter 30 of the Zoning Regulations, the fee charged shall be the greatest of all the fees computed separately. Computed separately, the Map Amendment and PUD fees are as follows:

- **Map Amendment Fee:** for the 294,649 square feet of land area to be rezoned to either the C-3-C or C-4 Zone Districts – \$73,662,25. (11 DCMR § 3041.1(g))



- **PUD Fee:**
 - **Residential:** for the 346,488 square feet of residential gross floor area that will be generated by the PUD – \$17,324.40 (11 DCMR § 3041.4(a))
 - **Other:** for the 1,441,757 square feet of other gross floor area that will be generated by the PUD – \$144,175.70 (11 DCMR § 3041.4(b))
 - **Total:** \$161,500.10

With regard to ZC Case No. 06-12, the fees for each of the two requested actions, computed separately, are a Map Amendment fee of \$73,662.25 and a PUD fee of \$161,500.10. The greatest of those two fees is the PUD fee. Accordingly, the hearing fee for Zoning Commission Case No. 06-12 is \$161,500.10.

Attached please find a check in the amount of \$166,500.10. That sum includes the \$5,000.00 fee for review of a Campus Plan for ZC Case No. 06-11 and the \$161,500.10 PUD fee for review of ZC Case No. 06-12.
