The above Applications were filed on May 11, 2007. Subsequent to the filing of the Applications and as a result of further discussions with the Office of Planning and community representatives, the Applicant has revised several of the elevations and sections of the proposed building in order to reduce the height of the building to a maximum of seventy (70) feet. (See one original and twenty copies of attached sheets A401, A402, A501, A502, A503 and A504.) In addition, the Applicant's revised plans eliminate the "occupiable" penthouse feature and add a small mechanical penthouse above the top floor. In summary, the revised project proposes that the highest full floor is developed at a height of sixty-one (61) feet and that a partial floor is constructed to a maximum height of seventy (70) feet. Please add this letter and the attached plans to the file. Thank you.




