4. Applications to the Zoning Commission will not be accepted until they have been reviewed by the Secretary to the Zoning Commission to ensure they are complete. Applicants will be notified when their applications are accepted.
5. If more than one owner is the subject of this application, complete a separate copy of this form for each owner.
6. ***At the time of filing this application, all Applicants are REQUIRED to submit the following information (including one (1) original and twenty (20) collated copies, except for labels, of which one (1) copy is required):***
 - A. A statement, using 8½" x 11" paper, clearly setting forth the reasons for the requested PUD modification. Additional information, exhibits, or photographs may be attached, if desired, provided they are also no larger than 11" x 17".
 - B. A key map (photocopy of the Zoning Map on 8½" x 11" paper) showing the subject property outlined in red and the zoning of the surrounding area.
 - C. A certified surveyor's plat of the subject property prepared by the D.C. Office of the Surveyor.
 - D. A statement indicating that the Applicant is in compliance with the requirements of Chapter 24 of Title 11 DCMR – Zoning Regulations.
 - E. All documents required pursuant to Title 11 DCMR §2409.9.

Please note: All applications are referred to the D.C. Office of Planning (OP). OP, pursuant to 11 DCMR §3011, reviews applications and submits written recommendations to the Zoning Commission advising whether the matter should be processed further.
