Joint Request from Georgetown University, Advisory Neighborhood Commission (ANC) 2E, the Citizens Association of Georgetown, and the Burleith Citizens Association for an Extension of Time

On April 2, 2012, the Commission granted the request of Georgetown University, ANC 2E, the Citizens Association of Georgetown, and the Burleith Citizens Association (the Parties) for a 60-day extension of time to facilitate in-depth discussions and negotiations regarding the Georgetown University 2010 Campus Plan. The Parties are pleased to report that the additional time has been and continues to be productive.

The Parties hereby request that the Commission modify the previously-established briefing schedule to grant the Parties a week of additional time, by extending the upcoming filing date from June 11 to June 18, 2012. The Parties propose the following schedule, which they anticipate could provide the Parties sufficient time to finalize an agreement and provide the remaining parties in the case, ANC 3D and the Foxhall Community Citizens Association, with an opportunity to file their written response one week later.

- June 18, 2012: Joint filing by Georgetown University, ANC 2E, CAG, and BCA (if a final agreement has been reached by the Parties; otherwise, filings as previously contemplated)
- June 25, 2012: Response by ANC 3D and FCCA (if a final agreement has been reached by the Parties; otherwise, filings as previously contemplated)
- July 9, 2012: Zoning Commission Public Meeting (status meeting to review the written filings and determine whether a limited hearing is required).
- July 16, 2012: Zoning Commission Special Public Meeting (final action if no limited hearing is required)

We are authorized to state that ANC 3D and the Foxhall Community Citizens Association support this request for additional time.

We greatly appreciate the Commission's consideration and the opportunity that the Commission is providing for the Parties to reach a common understanding.

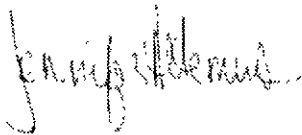
