**Re: Z.C. Order No. 10-32 – Georgetown University Campus Plan
Joint Motion for an Extension of Time to File Revised Campus Plan**

Dear Chairman Hood and Members of the Commission:

Pursuant to Condition 40 of Z.C. Order No. 10-32 (“Order”), Georgetown University is required to file a revised campus plan thirty days from the date of the Order. The date of the Order is October 10, 2012, and the revised campus plan is therefore due November 9, 2012. Condition 40 then permits the parties to review and comment on the revisions to the Campus Plan. The Zoning Commission is responsible for reviewing the comments and determining whether further proceedings are warranted.

The University has revised the campus plan and exhibits as required by the Commission. Prior to filing, the University would like to give the ANC 2E, CAG, BCA and FCCA an opportunity to review the draft plan and exhibits. Therefore, the University and the parties hereby jointly request that the Zoning Commission grant an extension of time by no more than eleven days (that is, to November 20, 2012).

The parties believe that the proposed extension of time will provide the parties with an opportunity to review the revised campus plan and exhibits as well as enable the parties to address any community comments prior to filing of the revised campus plan. The parties would still retain an opportunity to submit comments pursuant to Condition 40, but the extension of time would permit the University and parties to work collegially toward significantly reducing or eliminating the comments on the revised campus plan.

We appreciate the Commission’s consideration of this request and look forward to submitting a revised campus plan that reflects the cooperation and collaboration that was fostered through the campus plan process. We are authorized to state that the Foxhall
