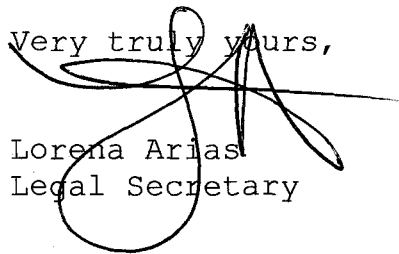

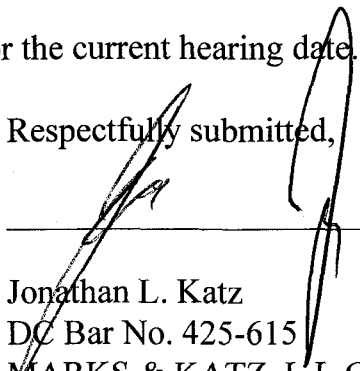
Mr. Long stated that the DCRA consents to JMM Corp.'s Motion to Reschedule the July 25, 2006, hearing.

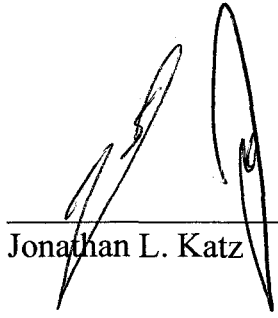

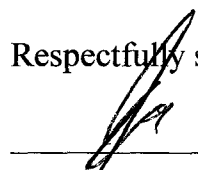

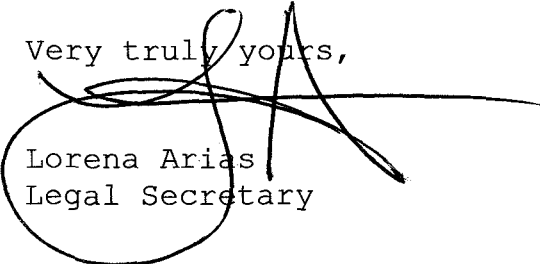
