Hi Mr. Prakash,

I am following-up on our phone conversation from earlier today. My understanding is that you do not want to do the Comprehensive Transportation Review (CTR) with DDOT without prior support from one of DDOT, the ANC, OZA, OP, or Office of Zoning (OZ). I recommend contacting Noah Hagen (Noah.Hagen@dc.gov) to try and resolve the issues and concerns you have with the DDOT process. There are a few things I need to note:

1. I want to reiterate that no single DC Agency or civic organization holds veto power over an application. The Board is charged with reviewing the application and zoning requirements and taking into consideration

technical reports from DC Agencies and community engagement (ANC, letters to the Board). I will also note that OZ does not provide the Board a recommendation and that the Zoning Administrator Memorandum is a way to determine what relief is needed, this can also be done through a Form 135 (self-certification, signed by a DC Licensed attorney or architect).

2. DDOT has previously informed me their process from the study to writing a report takes roughly 3 months from when the project scoping is agreed upon,
3. Per the Office of Planning report in exhibit 21 they cannot provide a recommendation without first reviewing DDOT's report.

It is also my understanding that there is not a Certificate of Occupancy for the proposed Gasoline Service Station and that BZA Order No. 17963 is expired, this would mean that there is not an Order to modify but a new special exception to be considered.

In order to properly notice your application we need the following information for a complete application pursuant to Subtitle Y 300.8

1. Revised list of all names and mailing addresses of property owners within 200 feet.
2. An updated ZA Memo or Self-Certification (form 135)
3. If to continue as a Modification of Significance, a Certificate of Occupancy for the gasoline service station use.

I recommend submitting this information to us as quickly as possible (i.e. the next week or so, say August 9th) so that way OZ can properly full-fulfill its noticing obligations in advance of the October 9th public hearing date.
