### **Party Status Criteria**

1. How will the property owned or occupied by such person, or in which the person has an interest be affected by the action requested of the Commission/Board?  
As a home owner living in a mixed-use block (Square 902), I have spent thousands of dollars in my efforts to keep rats out of my house. Any action related to food disposal in the block has an impact on the rat population. The applicant conducts business in this square. Thus, the applicant's proposal has a direct impact on my property.
2. What legal interest does the person have in the property? (i.e. owner, tenant, trustee, or mortgagee)  
I own the property.
3. What is the distance between the person's property and the property that is the subject of the application before the Commission/Board? (Preferably no farther than 200 ft.)  
My property is approximately 160 feet from the applicant's property.
4. What are the environmental, economic, or social impacts that are likely to affect the person and/or the person's property if the action requested of the Commission/Board is approved or denied?  
The food-related trash at the applicant's property is a major food source for rats in the block. From there, the rats disperse throughout the block, creating burrows or entering homes and businesses. This poses a major health risk to those living in the block.
5. Describe any other relevant matters that demonstrate how the person will likely be affected or aggrieved if the action requested of the Commission/Board is approved or denied.  
If a proper indoor trash room is constructed and used properly, the rat population will have lost a major food source and aid in the square's efforts to control the rat population.
6. Explain how the person's interest will be more significantly, distinctively, or uniquely affected in character or kind by the proposed zoning action than that of other persons in the general public.  
The rats currently obtaining food at the applicant's property have an impact on those living Square 902. It is in this square that the majority of the rats seek homes, thus posing a health risk.
