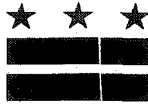

Dear Advisory Neighborhood Commission 1A:

This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of Triangle Development Associates LLC, pursuant to 11 DCMR §§ 3104.1, and 3103.2, for a variance from the floor area ratio requirements under section 771.1, and a variance from the lot occupancy requirements under section 772.1, and a special exception to reduce the amount of parking spaces required for nonresidential uses under section 2108, to allow an addition to an existing residential building with ground floor retail space in the C-3-A District at premises 1375 Kenyon Street, N.W. (Square 2843, Lot 78).

The hearing will be held on Tuesday, November 1, 2011, at 441 4th Street, N.W., Suite 220 South, Washington, D.C. 20001. This application will be heard between 9:30 a.m. and 12:00 p.m.

You are advised that 11 DCMR Section 3115.1 sets out certain requirements related to reports of ANCs, and specifically that Section 3115 requires that the written report of the ANC be filed with the Board at least seven days in advance of the hearing. Form 129 – Advisory Neighborhood Commission (ANC) Report, which is enclosed for your convenience, is the preferred mechanism to complete this report. 3. Submission deadlines are as follows:

For Zoning Commission:

- a. ANCs must file this form at least seven (7) calendar days in advance of the hearing, if they wish to participate in a contested case under § 3022.
- b. ANCs may file this form as long as the case record is open, if they wish to participate in a rulemaking case under § 3021.

For Board of Zoning Adjustment:

- a. ANCs must file this form at least seven (7) calendar days in advance of the hearing.
