This is to advise you that a public hearing has been scheduled by the Board of Zoning Adjustment to consider the following application that is located within the boundaries of your ANC area:

Application of Keener-Squire Properties, on behalf of the First Baptist Church of the City of Washington, pursuant to 11 DCMR §§ 3103.2 and 3104.1, for a special exception for roof structures of unequal height pursuant to section 411, and for variances from the location of compact parking spaces under subsection 2115.4, and the height provisions under section 530, to allow the development of an apartment house as an addition to an existing church building in the DC/SP-1 and DC/SP-2 Districts at premises 1328 16th Street, N.W. (Square 181, Lot 163).

The hearing will be held on Tuesday, November 15, 2011, at 441 4th Street, N.W., Suite 220 South, Washington, D.C. 20001. This application will be heard between 9:30 a.m. and 12:00 p.m.
