Project: A modification of significance from Board of Zoning Adjustment Order No. 18400B, to increase the number of students to 425, and to increase the number of staff members to 87 of an existing private school in the R-1-B and RA-1 Zones.

You will need to create a username and password if you have not done so already.

C. Submit a statement into the record: After reviewing the record, submit written testimony, either a letter in support, or a letter in opposition. Submissions are **required to be sent at least 24 hours before the hearing**.

- Hard copies of documents will not be accepted at this time.
