The ANC 4C Commission, at a duly noticed public meeting, with a quorum of 9 Commissioners present at its September 13, 2017, meeting, voted, with 8 Yeas, 0 Nays, and 0 Abstentions (1 Commissioner was temporarily absent) to request a postponement of the hearing for BZA case #19564 scheduled for September 27, 2017.

The request is to give the applicant more time to attempt to meet with neighbors. At the time of the meeting the applicant had not been able to meet with neighbors. The applicant and their representatives were present for the ANC discussion and vote to request a postponement. The ANC would request a hearing date after October 11, 2017, when ANC 4C will hold our October meeting and potentially reconsider this case request.

The Commission also voted with 8 Yeas, 0 Nays, and 0 Abstentions (1 Commissioner was temporarily absent) to appoint the Commissioner for Single Member District 4C10, or any member of the Executive Committee in their absence, to be authorized to communicate this resolution and represent ANC 4C before the BZA related to this matter.
