In light of the lengthy record for the case, Party Status Opponent Sheridan-Kalorama Neighborhood Council ("SKNC") would like to bring to the Board's attention a number of letters in opposition recently filed into the record by neighbors, including the immediate neighbor to the west of the subject property, David Feigin (Exhibit 109), a neighbor who watches the Gold Star Mothers building (Exhibit 112), and the family that has lived at the Fazl Mosque for 23 years (Exhibit 116).
