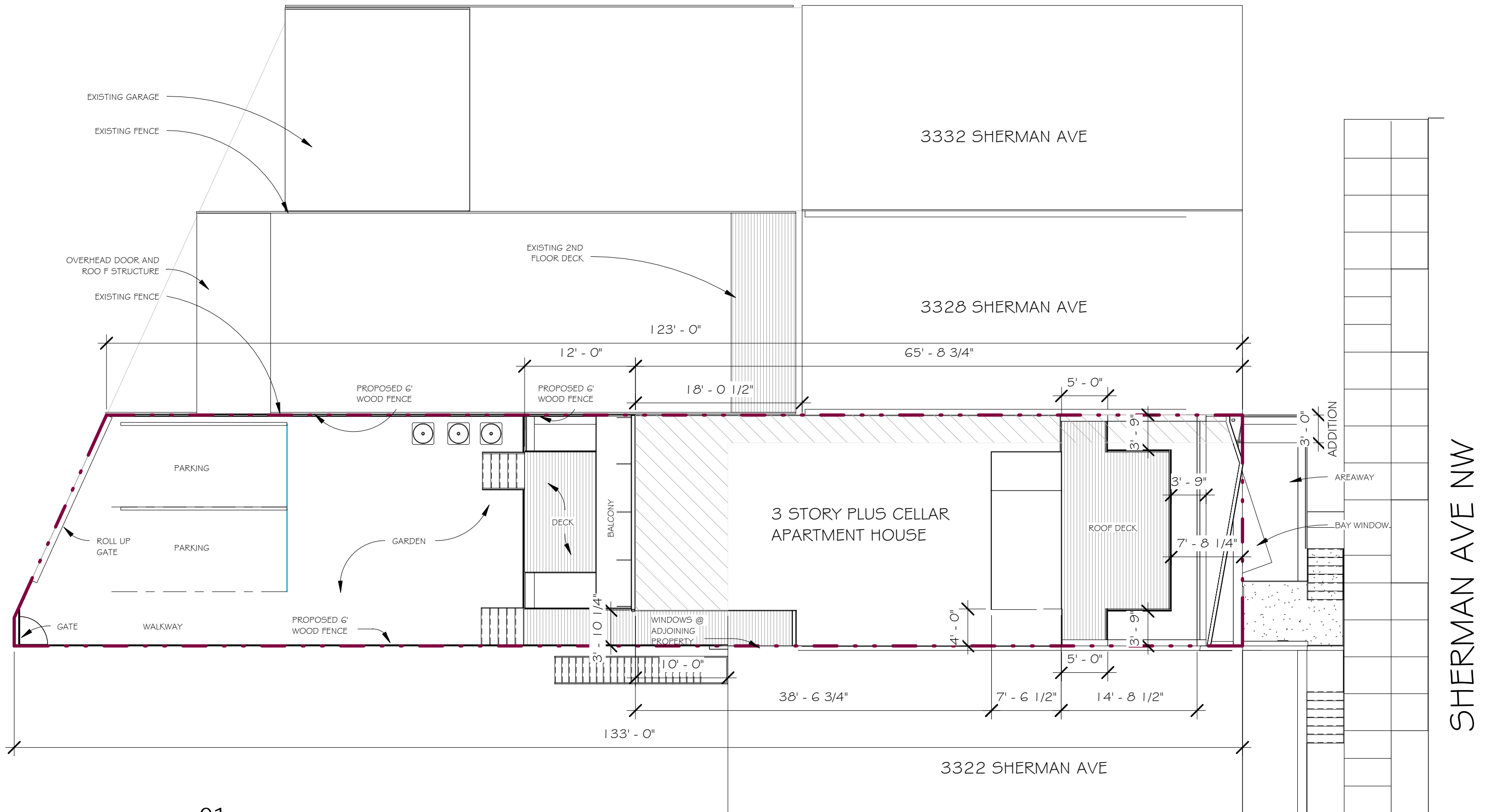

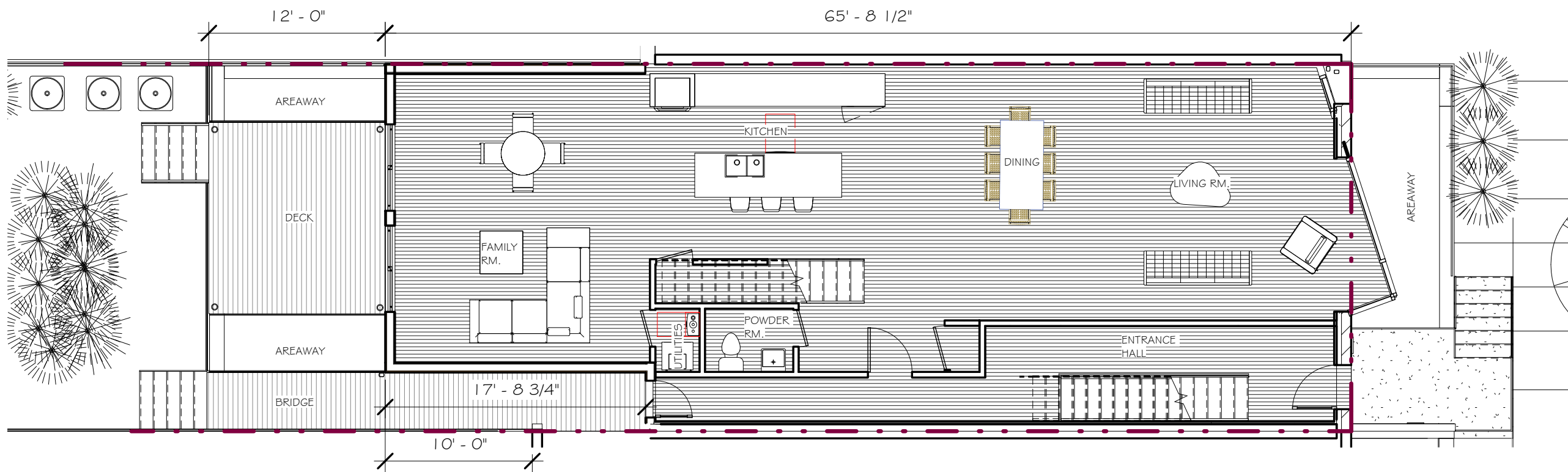

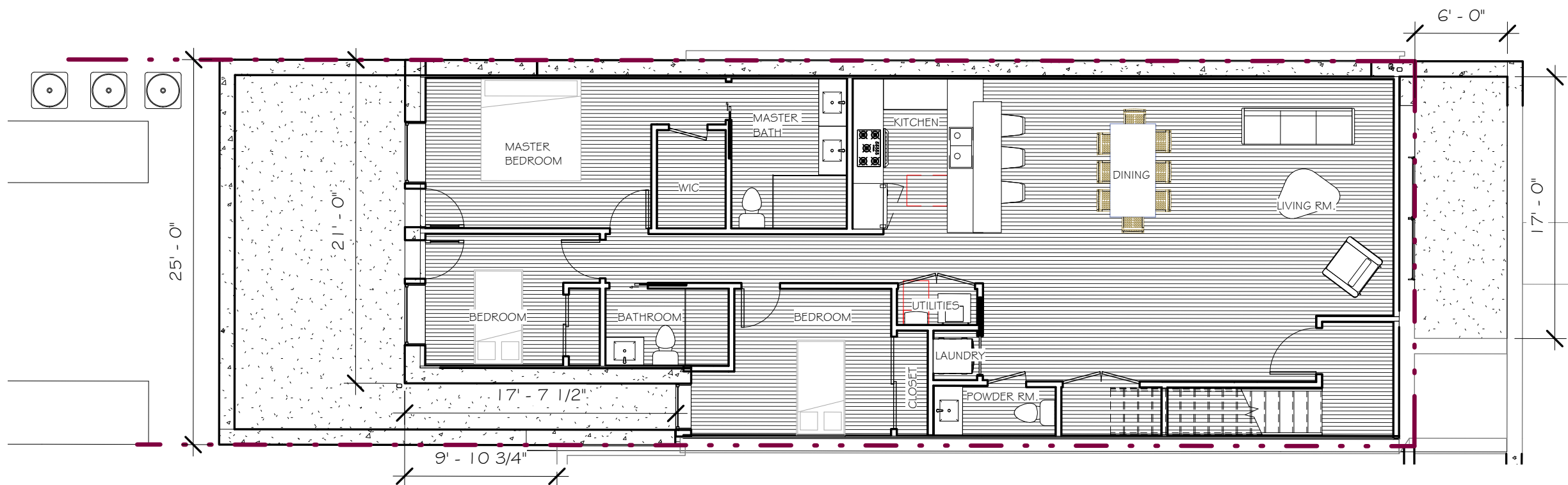

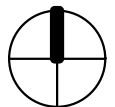
01 Site Plan BZA

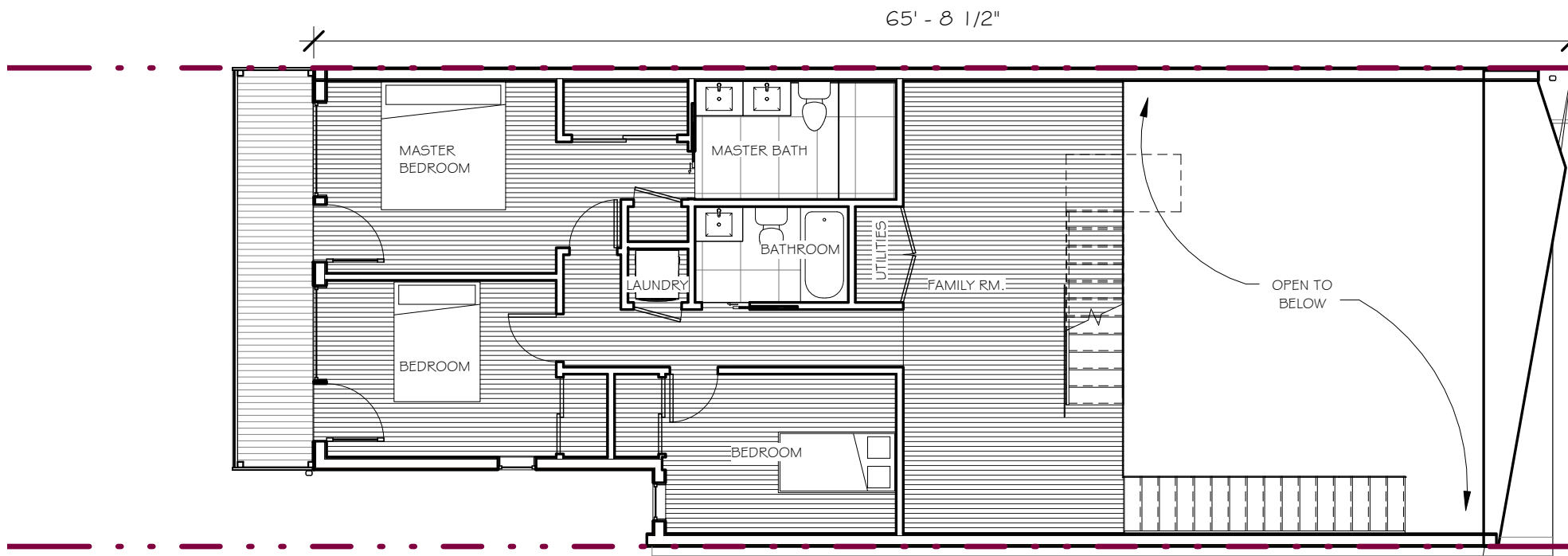

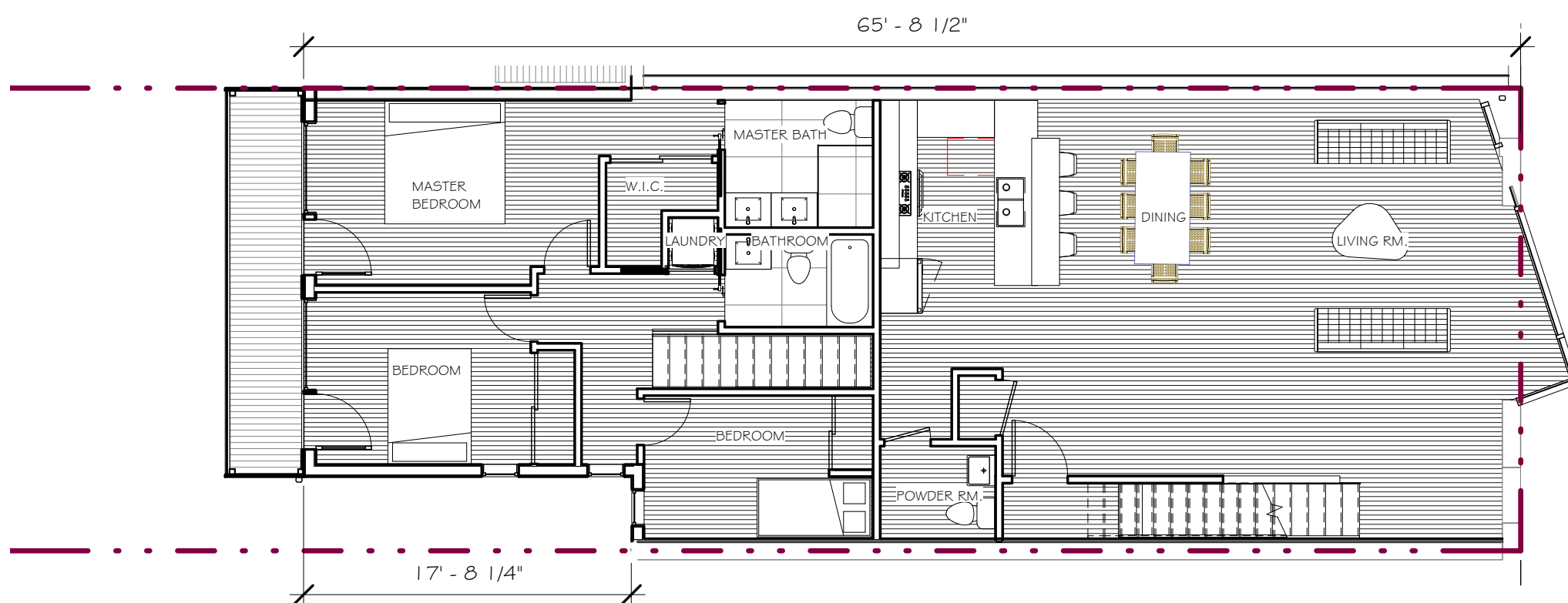

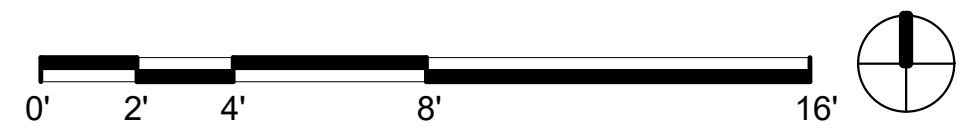

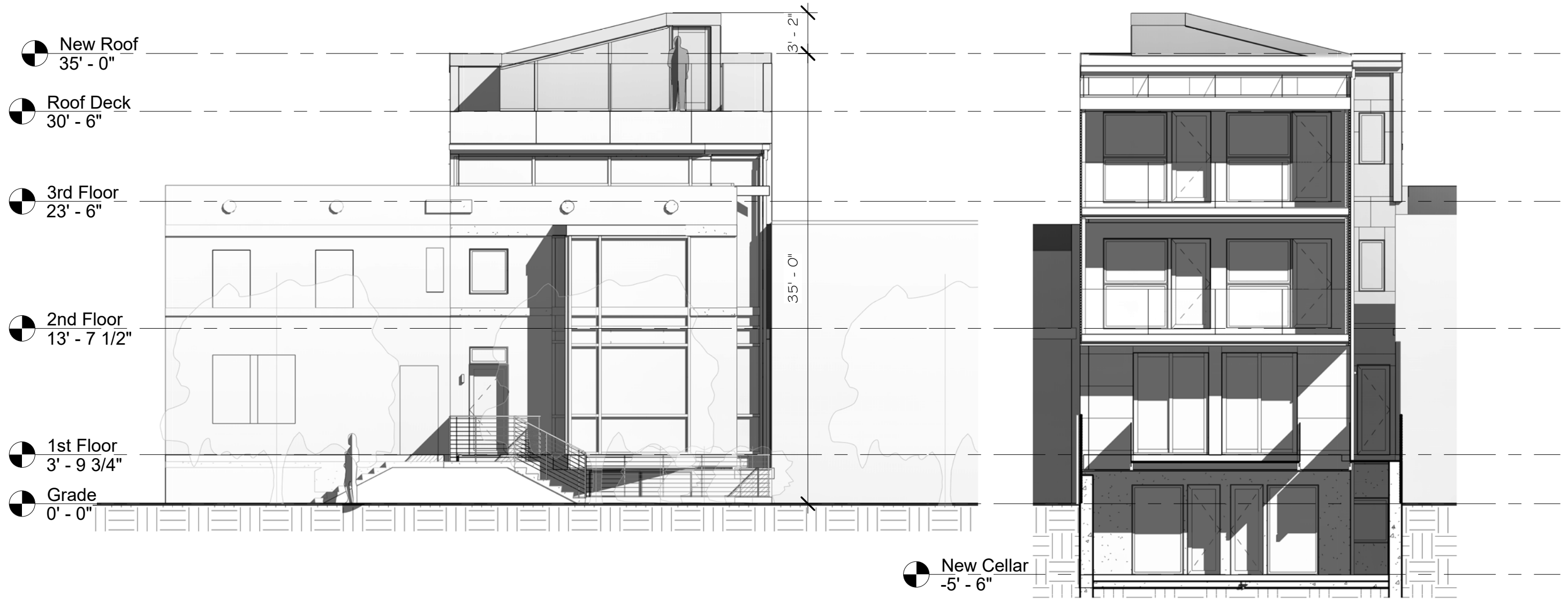

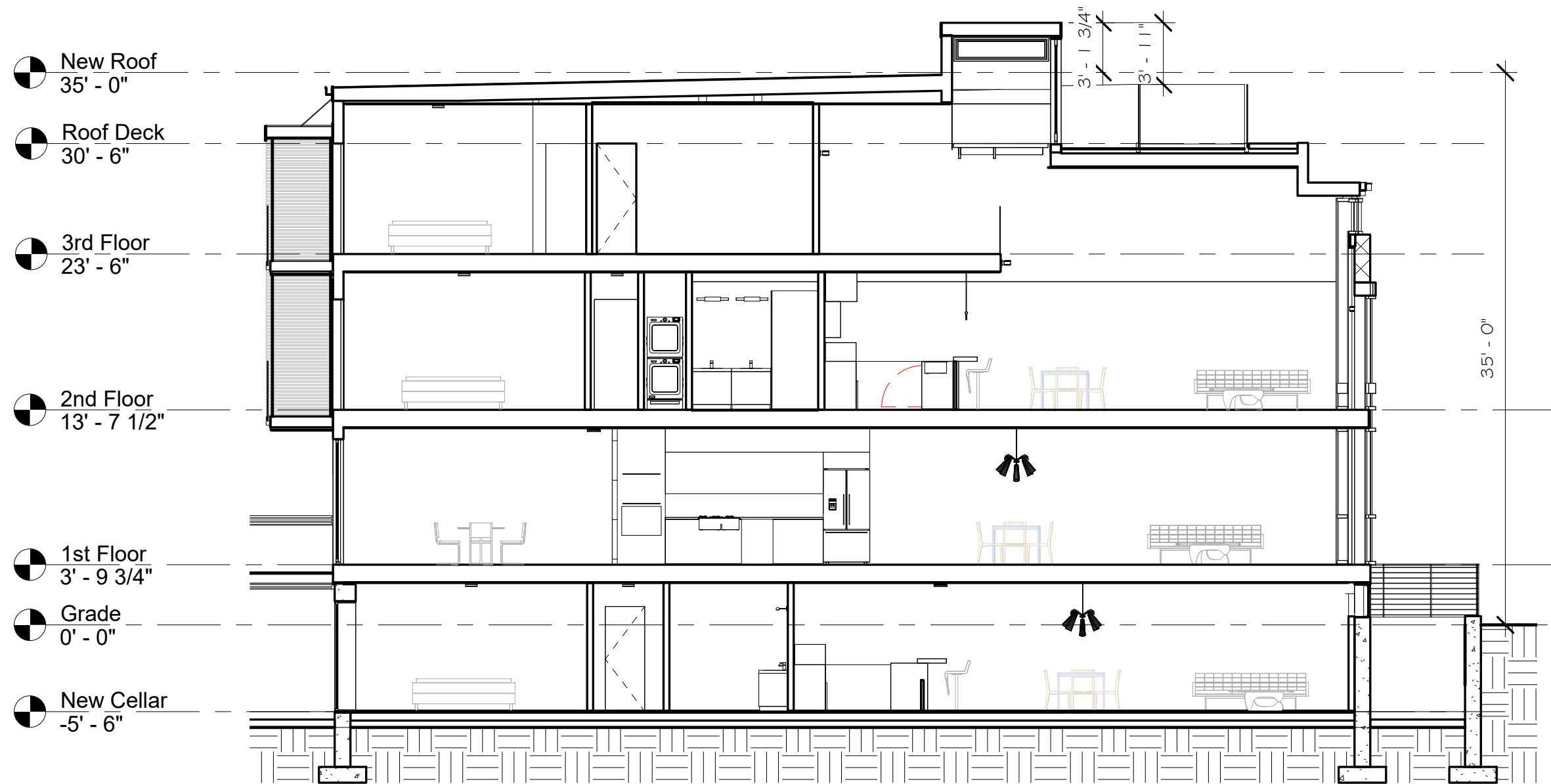
