#### REFERRAL MEMORANDUM AND NOTICE OF PUBLIC HEARING

Dear ANC Single Member District Commissioner:

An Applicant within the boundaries of your ANC Single Member District is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district. This application was filed on May 9, 2018 through the Interactive Zoning Information System (IZIS).

A public hearing has been scheduled by the Board of Zoning Adjustment (Board) on <u>Wednesday, July</u> 18, 2018 at 9:30 am, at the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4<sup>th</sup> Street, N.W., Suite 220 South, Washington, D.C., 20001, concerning the following application:

**Application of Community Three Grimke, LLC,** pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception under Subtitle K § 813 from the rear yard requirements of Subtitle K § 805.1, and pursuant to Subtitle X, Chapter 10, for variances from the parking access requirements of Subtitle C § 711.3(b), and from the drive aisle width requirements of Subtitle C § 712.5, to renovate and expand the existing former school building and convert it to a mixed-use building in the ARTS-2 Zone at premises 1925 Vermont Avenue N.W. (Square 361, Lot 827).
