## #19804 Case Log Clarification

Board of Zoning Adjustment Chairperson Hill 441 4th Street, NW, Suite 200S Washington, DC 20001

ANC 4C is requesting this letter be added to the case files for #19804 to clarify previously submitted statements from one of our Commissioners due to the erroneous nature of those statements

In Exhibit #52 an ANC 4C Commissioner stated: "At the properly noticed September 12, 2018 Public Meeting of ANC4C with 8 Commissioner present.Six constituted a quorum The 4C voted 4 against 2 in support with 2 abstaining. To a letter of support introduced by Chair Bennent [sic] Hilley Internal Commission policy precludes the introduction of documents at least 48 hours prior to a vote. Thus a letter of Opposition wasn't voted on AS the SMD Commissioner."

ANC 4C voted on a motion to support the application and that motion was in order. The motion failed 3-4-1. Both the Commissioner's statement that the motion wasn't voted on and the vote tally were submitted incorrectly in this exhibit. ANC 4C voted on a second motion to oppose the application and that motion was also in order. The motion to oppose passed 3-2-2.

In Exhibit #61 the Commissioner misstated the vote from two Commissioners. The Commissioner from 4C01 abstained and the Commissioner from 4C04 voted against the motion to oppose.

Furthermore, ANC 4C did not take any stance on this development although the Form 129 suggests both issues and recommendations coming from the Commission. These statements are solely from the SMD Commissioner. Per our Commission by-laws these statements should not have been submitted on behalf of the Commission. Instead, the resolution voted on at this meeting should have been submitted for the Board's review.

We apologize for the incorrect statements and our need to request corrected documentation be placed into the record on this case. We are addressing these process issues to prevent this from happening going forward.

We are requesting the Board hold the record open until November 15, 2018 to allow us time to vote on this at our upcoming meeting.
