Application of Halcyon Georgetown, LLC, pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception under the use provisions of Subtitle U § 203.1(n), to permit a nonprofit use in a residential building in the R-20 Zone at premises 3400-3410 Prospect Street N.W. (Square 1204, Lot 63).
