The Board of Zoning Adjustment (Board or BZA) will consider the following application during the public hearing session scheduled for **Wednesday, December 11, 2019 beginning at 9:30 a.m.**, in the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4th Street, N.W., Suite 220 South, Washington, D.C., 20001:

Application of Southern Hills LP, pursuant to 11 DCMR Subtitle Y § 704, for a modification of significance to the approved plans, to demolish the existing seven building apartment complex and to construct six apartment houses with a total of 349 residential units, and a new community service center in the RA-1 Zone at premises 4201, 4209, 4219, 4333, 4337, and 4347 4th Street S.E. and 304 Livingston Terrace S.E. (Square 6167, Lots 45, 46, 47, 48, 49, 50 and 51).
